THE REFERENCE VIRAL DATABASE DOWNLOAD AND USE AGREEMENT

The Reference Viral Database (RVDB) was created by the U.S. Food and Drug Administration (FDA), an agency of the United States Government (Government), using nucleotide sequences made publicly available by National Center for Biotechnology Information (NCBI) and is hosted by the University of Delaware, Center for Bioinformatics and Computational Biology (UD). The FDA and UD are collectively, the "Providers". RVDB contains unmodified viral, viral-related, viral-like sequences and associated record information from NCBI databases including Genbank, viral RefSeq, viral neighbor genomes, and Third-Party Annotations (TPA). The FDA created RVDB to provide a database enriched for viral sequences and associated metadata for broad virus detection. RVDB is made available to the public by the FDA and hosted by UD. BY DOWNLOADING RVDB, THE PARTY DOWNLOADING RVDB (THE RECIPIENT), AGREES TO THE FOLLOWING TERMS:

- 1. It is the intent of the Providers that RVDB be available for use by the public. The Recipient may use, reproduce, and create derivatives of RVDB and the Recipient may share or distribute RVDB and derivatives of RVDB to others.
- 2. The Providers makes no representations or warranties regarding the content or accuracy of the information contained in RVDB and associated files. The Providers also make no representations or warranties of merchantability or fitness for a particular purpose or that the use of RVDB, its sequences, metadata or associated information will not infringe any patent, copyright, trademark, or other rights. The Providers accept no responsibility for any consequence of the Recipient's receipt or use of RVDB or any information contained in RVDB. Further, the Providers accept no responsibility for any consequences of the Recipient's receipt or use of RVDB and any information contained in RVDB. RVDB or derivatives of RVDB. The RVDB and any information contained in RVDB or associated with RVDB is being provided AS-IS.
- 3. In no event will the Providers be liable to the Recipient for any damages incurred by Recipient, including but not limited to direct, indirect, special or consequential damages, arising out of, resulting from, or in any way connected with the Recipient's use of RVDB and its sequences, information or metadata.
- 4. Recipient will not claim, infer or imply Providers' endorsement of RVDB, results obtained by Recipient, and analyses performed by Recipient using RVDB and its sequences, information or metadata, in any promotional advertising or other promotional materials.
- 5. RVDB, including but not limited to, its sequences, information or metadata are not intended by Providers to be used as a regulatory standard.
- 6. In accordance with academic standards, Recipient should cite to the original submitters of sequences and metadata used in academic publications. For the RVDB, recipients should cite to:

- 7. The FDA may offer RVDB to others under separate terms or conditions and may stop updating RVDB or making RVDB publicly available at any time. Additionally, UD may stop hosting RVDB at any time. These actions will not terminate this Agreement with respect to Recipient's use of copies of RVDB downloaded prior to these actions.
- If Recipient shares or distributes RVDB or derivatives of RVDB to third parties, the terms of agreement between the Providers and third-party will include the Provider's disclaimers and terms of paragraphs 2-6, namely, a disclaimer of Provider's warranties and liability (p. 2 and p. 3), a statement that RVDB is not intended to be used as a regulatory standard (p. 5), a notice of no endorsements by Providers (p. 4), and the requirement for attribution in academic publications (6).
